SYNOPSIS

A motion is requested to award a contract for FY07 Tree and Stump Removal Services to Steve Piper & Sons, Inc. of Naperville, Illinois in the amount of \$118,415.

STRATEGIC PLAN ALIGNMENT

A *Beautiful Village* is one of the eight principles identified in the Downers Grove Vision 2021 statement. Among other things, this principle means *Tree Canopied Streets* and *Well Maintained Streetscapes, Green Spaces and Landscapes*.

FISCAL IMPACT

The adopted FY07 General Fund budget provides \$100,000 for tree and stump removal services. Staff will reduce spending in other areas within this program of the General Fund in order to remain within budget.

RECOMMENDATION

Approval on the January 16, 2007 consent agenda.

BACKGROUND

The contract to provide services for tree and stump removal was competitively bid for FY 2007, with three bids received. The bids received are summarized on the attached bid tabulation.

The purpose of this contract is for the removal of trees and stumps from parkways, Village properties, and unimproved right-of-ways and alleys. These removals are necessary because of tree death, hazardous conditions, and infectious diseases such as Dutch Elm disease. The contract amount is based on the average annual number of trees and stumps removed in the past seventeen years. Because of this, the numbers for trees and stumps are not equal and may differ as a result of in-house removals, storm damage losses, and tree removals in unimproved right-of-ways where stumps may not be removed.

Steve Piper & Sons, Inc. has previously had this contract with Downers Grove in FY 2006 and it was successfully completed. For reference, the amount spent on this contract for FY 2006 was \$111,052.11.
