SYNOPSIS

A motion is requested to award a contract for FY07 Mowing Services to The T.L.C. Group, Ltd. of Clarendon Hills, Illinois in the amount of \$29,999.98.

STRATEGIC PLAN ALIGNMENT

A *Beautiful Village* is one of the eight principles identified in the Downers Grove Vision 2021 statement. Among other things, this principle means *Well Maintained Streetscapes*, *Green Spaces and Landscapes*.

FISCAL IMPACT

The adopted FY07 General Fund budget provides \$34,625 for mowing services.

RECOMMENDATION

Approval on the January 16, 2007 consent agenda.

BACKGROUND

The contract to provide mowing services was competitively bid for FY07, with three bids received. The bids received are summarized on the attached bid tabulation. The lowest responsive and responsible bidder meeting the Village's specifications is The T.L.C. Group, Ltd. of Clarendon Hills, Illinois. Their references are all positive.

The purpose of this contract is for the mowing and trimming of turf located throughout the Village. The contract has 3 sets of locations that vary by their mowing frequency:

- Fine moving locations are the prominent Village property areas to be moved frequently or approximately once a week (estimated 28 moving events)
- Rough mowing locations need to be mowed less frequently or once every 3 weeks (estimated 9 mowing events)
- Very rough mowing locations are to be moved once a month (estimated 5 mowing events)
- In addition, hourly prices were also submitted in case additional mowing may be needed for locations not included in any of the above.

The timeframes listed in the contract are for when turf normally starts growing in April and stops in November.
