Mr. Sumek suggested that the Council might want to add the downtown area as a goal as it was mentioned many times at last night's Citizen Summit. He further suggested referring the economic development goal to the Economic Development Corporation.

Mr. Sumek outlined the agenda for session "Looking to Downers Grove's Future."

Each Council member was asked to outline five topics regarding the state of the Village in 2022, five major challenges, three focus areas for 2012 and five items on their agenda for 2007-08.

Mr. Sumek outlined the following threats to realizing our vision:

- 1) Retail and Village's sales tax base
- 2) Legislative actions
- 3) Service expectations with rising service delivery cost
- 4) Capital needs within the Village
- 5) Housing stock
- 6) Sustainable authentic downtown
- 7) Changing community

Staff made a presentation regarding each threat.

Mr. Sumek reviewed the top ten priorities for 2007:

- 1) Watershed improvement plan
- 2) Parkway trees plan, funding and action
- 3) Downtown pattern book and regulatory changes
- 4) Market compensation study and policy (directors and assistant directors)
- 5) Design and construction standard update
- 6) Development of neighborhood infrastructure plan
- 7) CIP comprehensive review
- 8) Customer service training and evaluation
- 9) Performance management training program
- 10) Village Civic Center facilities: Policy direction, funding and actions

The meeting was adjourned at 8:30 p.m.
