SYNOPSIS

A motion is requested to renew the Class A Scavenger License assigned to Allied Waste, Inc. through March 31, 2008. This license, which can be assigned to only one vendor, authorizes the scavenger to collect garbage, recyclables and compostable material from all premises within the Village.

RECOMMENDATION

Approval on the December 18, 2007 consent agenda.

BACKGROUND

Pursuant to the Municipal Code, Scavenger Licenses are to be renewed annually. Class "A" license holders may provide collection services from residential properties served under the Village's contract for solid waste collection and disposal services, in addition to separately contracted commercial and multifamily facilities. Renewal of a Class "A" license requires approval by the Village Council. A resolution approving the Village's Solid Waste Collection and Disposal Contract effective April 1, 2008 is currently pending before the Village Council, which, if approved, would provide for a new contractor to perform the services. Following the approval of the contract, staff will return to request that the Village Council approve a separate motion authorizing approval of the Class A Scavenger License to coincide with the effective date of the new contact for the remainder of 2008.

The current Village contractor for residential refuse and yard waste disposal services is Allied Waste Inc., 5050 West Lake Street, Melrose Park, Illinois. The contract extends through March 31, 2008. Allied Waste Inc. holds a 2007 Class "A" license and pursuant to the Municipal Code, will be required to submit the completed application form for the 2008 Class A license along with the required \$300 fee. The complete application materials are on file in the Village Clerk's Office.

Class B license holders may provide collection services from properties other than those served by the Village's solid waste collection and disposal contract. Renewal of a Class B license requires approval by the Village Manager, following notification to the Village Council.
