SYNOPSIS

A motion is requested to authorize a waiver of permitting, plan examination, and inspection/testing fees in the amount of \$5,513.70 as requested by St. Joseph Church for property at 4801 Main Street.

UPDATE & RECOMMENDATION

This item was discussed at the November 27, 2007 Workshop. At the request of Council, the item was placed on the active agenda to allow Commissioner Waldack to recuse him from voting on this item.

BACKGROUND

Approval of this motion would waive fees in accordance with the Village Council Policy for "Fee Waivers" (Res. 2002-73), which allows a complete waiver of the fee waiver request for not-for-profit, charitable, religious, or public service organizations.

St. Joseph Church is seeking a waiver of permitting, plan examination, and inspection/testing fees in the amount of \$5,513.70 for a lower level remodel of the organization's property located at 4801 Main Street. The lower level remodel includes the following: lighting, floor and wall finishes, partitions and painting. St. Joseph Church is a religious organization which provides worship and educational services to members of its congregation. As such, the organization is eligible for a waiver of fees per Section 1.29 of the Municipal Code.
