SYNOPSIS

A motion is requested to authorize award of a contract to Marcott Enterprises, Inc. of Addison, Illinois, as the lowest responsible bidder for debris hauling and crushed limestone supply services in the amount of \$179,762.50.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identified *Top Quality Village Infrastructure and Facilities*.

FISCAL IMPACT

The FY08 Municipal Budget includes \$225,100 for debris hauling and crushed limestone supply. Of this amount, \$77,580 is budgeted in the General Fund, \$88,320 is budgeted in the Stormwater Improvement Fund, and \$59,200 is budgeted in the Water Fund.

RECOMMENDATION

Approval on the March 18, 2008, consent agenda.

BACKGROUND

The contract to provide debris hauling and crushed limestone supply services was competitively bid for 2008 with six bids received as summarized in the bid tabulation below. The contract amount is based on the hauling and disposal of approximately 530 semi-truck loads of debris as well as supplying about 1,825 tons of crushed limestone.

The low responsible bidder, Marcott Enterprises, has not worked for the Village previously but had positive references from the City of Elmhurst and the Villages of Addison, Villa Park, Bensenville and Glen Ellyn.




