**SYNOPSIS**

A motion is requested to award a contract for the supply of hot mix asphalt materials to Chicago Materials Corporation of Lemont, Illinois, as the lowest responsible bidder in the amount of \$69,000.

**STRATEGIC PLAN ALIGNMENT**

The Five Year Plan and Goals identified *Top Quality Village Infrastructure and Facilities*.

**FISCAL IMPACT**

The adopted FY08 Capital Projects Fund budget provides \$65,000 for the purchase of asphalt materials. An amendment to the FY08 Capital Projects Fund budget may be required at fiscal year end if staff is unable to identify other projects for savings or deletions to cover the additional \$4,000 above budget.

**RECOMMENDATION**

Approval on the March 18, 2008, consent agenda.

**BACKGROUND**

The supply of asphalt materials for 2008 was competitively bid and resulted in three responses meeting specifications as summarized below.

Chicago Materials Corporation, Lemont, Illinois	\$69,000.00	\$46.00
Central Blacktop Co., Inc., La Grange, Illinois	\$70,500.00	\$47.00
James D. Fiala Paving Co., Inc., Bolingbrook, Illinois	\$71,250.00	\$47.50

This purchase provides for approximately 1,500 tons of materials to be used for street repairs at various locations throughout the Village. This price is free on board at the Chicago Materials Corporation site and will be picked up by Village staff when materials are needed. Annual street repair work will begin in April and continue through October. The contract in 2007 was with Chicago Materials Corporation and the price for asphalt materials in 2007 was \$42.50 per ton.

Chicago Materials Corporation is a subsidiary of K-Five, Inc. The Village has used this supplier for asphalt in the past and has had good experience with this firm.
