BE IT ORDAINED by the Village Council of the Village of Downers Grove in DuPage County,

### Section 1. That Section 28.401. is hereby amended to read as follows:

### 28.401. Zoning Map.

The boundaries of each district are set forth upon the amended zoning district map of the Village of Downers Grove titled "Village of Downers Grove, Illinois, 2007\( \bar{8} \) Zoning Map Corrected to \( \frac{03-20-0703-18-}{08} \)". This zoning map is hereby incorporated into and made a part of this Zoning Ordinance as if fully set forth herein.
