- 4. That all resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.
- 5. That this Resolution shall be in full force and effect from and after its passage as provided by law.

AN EXTENSION TO THE CONTRACT BETWEEN THE VILLAGE OF DOWNERS GROVE AND GEN POWER, INCORPORATED

The Village of Downers Grove, Illinois (the "Village") and Gen Power, Incorporated ("Gen Power") entered into a Request For Proposal ("RFP") agreement for generators for Heritage Festival on or about March 8, 2006. Pursuant to the terms stated therein, the parties desire to extend that contract for the 2008 Heritage Festival to be held June 26-29, 2008 under the following terms:

- 1. All prior terms from the 2006 RFP Agreement remain in full force and effect, except as specified below.
 - a. The equipment shall be set up according to a schedule which will be documented after a joint meeting between the parties on or before Thursday, May 15, 2008.
 - b. The Village shall pay to Gen Power the sum of \$15,262.00, an increase of 2% over the 2006 agreement, for rental of the equipment including labor to connect equipment.
 - c. Should additional equipment be needed for enhancing the event, Gen Power agrees to charge the same unit price per piece of equipment.
 - d. The rental payment shall be due upon receipt of final invoice after the event. The final check shall be mailed by approximately July 17, 2008, if invoice is received prior to July 3, 2008.
 - e. Removal of the equipment shall not begin before 10:30 p.m. on June 29, 2008 and must be completed by 4:00 a.m. on June 30, 2008.
 - f. Per the Village purchasing policy, this is the last option to extend for the 2008 Heritage Festival.
