Purpose: An ordinance has been prepared to change the zoning of two manufacturing parcels at

715-719 Rogers Street from M-1 to DT. An ordinance has been prepared for a Final Planned Development with a Variance to construct 16 townhouses. A Plat of Subdivision resolution has been prepared that will subdivide the two separate parcels into 17 individual parcels. A Special Use Ordinance has been prepared for dwellings

exceeding one unit per 4,000 square feet of land area.
