SYNOPSIS

A motion is requested to authorize a purchase of twenty-seven (27) ruggedized laptop computers (Panasonic Toughbooks Model Number CF-30 and CF19) from CDS Office Technologies for a total amount of \$98,192.00.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2006-2011 identified *Exceptional Municipal Organization* as a goal. A supporting objective of this goal is *Top Quality Core Services Responsive to Current and Future Community and Citizen Needs*. This purchase will directly impact the achievement of this objective.

FISCAL IMPACT

The FY08 Municipal Budget includes \$120,000 for Public Safety laptop replacement.

RECOMMENDATION

Approval on the May 20, 2008, consent agenda.

BACKGROUND

This purchase is to replace twenty ruggedized laptops in fire department equipment and seven ruggedized tablet computers that are used in ambulances for EMS reporting. The laptops currently being used were purchased as part of a major public safety system upgrade in FY01-02. In March 2008 the Village issued a Request for Proposals (RFP) for this purchase and received five proposals as outlined below. Staff recommends purchasing the laptops from CDS Office Technologies, the lowest bidder. The Village recently purchased Police Department laptops from CDS Office Technologies. Staff has had good experiences purchasing from CDS Office Technologies in the past.
