SYNOPSIS

A motion is requested to award a contract for the 2008 Pavement Marking – Preformed Plastic in the amount of \$69,155.00 to Marking Specialists Corporation.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2007-2012 identified *Exceptional Municipal Organization*. A supporting objective of this goal is *Top Quality Village Infrastructure*.

FISCAL IMPACT

The low bid is in the amount of \$69,155. The FY08 General Fund Budget allocates \$40,000 for this project; staff will utilize the additional \$29,155 amount from cost reductions already planned on the street light shroud project. The net result will be that there will be sufficient funds to complete both projects.

BACKGROUND

Pursuant to the Village Council's Purchasing Policy, the Village has requested bids from vendors that provide this service. The Village has received three bids for this contract, summarized below.

AC Pavement Striping Co.	\$118,024.50

Marking Specialists Corporation is pre-qualified by the Illinois Department of Transportation for work of this scope. Marking Specialists Corporation has performed satisfactory work for the Village, most recently in 2004.


