**SYNOPSIS**

A motion is requested to award a contract for the 2008 Pavement Marking – Thermoplastic to Superior Road Striping, Inc. on a per unit cost basis for a total, not-to-exceed the budgeted amount of \$23,000.

**STRATEGIC PLAN ALIGNMENT**

The Five Year Plan and Goals for 2007-2012 identified *Exceptional Municipal Organization*. A supporting objective of this goal is *Top Quality Village Infrastructure*.

**FISCAL IMPACT**

The low bid for the items and quantities estimated on the bid forms is in the amount of \$26,525. The FY08 General Fund Budget allocates a total of \$23,000 for this work. Since this is a unit price contract, staff will limit work to the amount budgeted.

**BACKGROUND**

Pursuant to the Village Council's Purchasing Policy, the Village has requested bids from vendors that provide this service. The Village has received five bids for this contract, summarized below.




