SYNOPSIS

A motion to authorize a change order for the telephone system at new Fire Station 2 in the amount of \$5,715.00 to Sound, Inc. of Naperville, Illinois, is requested. The change order provides for emergency lines and other functional components that were omitted from of the initial scope.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2007-2012 identified *Exceptional Municipal Organization* and the supporting objectives of *Top Quality Core Services Responsive to Current and Future Community and Citizen Needs*.

FISCAL IMPACT

The Fire Station 2 project budget spans three fiscal years (FY06, 07 and 08). The total project budget is \$10.5 million. The original contract amount for the phone system was \$14,960. The change order would increase the contract amount to \$20,675. There are currently sufficient funds available in the Fire Station 2 project budget from contingencies and savings from other aspects of the project to cover the increase in the contract amount.

RECOMMENDATION

Approval on the June 17, 2008, consent agenda.

BACKGROUND

The Village contracted with Sound Inc. of Naperville, Illinois to install the telephone system in Fire Station 2. It was recently observed that the original scope of work for the phone system did not include the installation of emergency communication phones called "hot lines" in all the locations necessary to make the system function properly. The hot lines are the station's direct link with the Village Operation Center (VOC) and function as a primary source of communication in the event of an emergency occurring at the station such as a walk-in patient. The hot lines also serve as a back-up to the alerting system in the event the primary paging system fails.

The change order would supply phones to each of the four exterior sides of the building near entryways and two in the interior of the firefighter's quarters.

The change also includes some essential components to the regular phone system. These components, like the hot lines, were planned on during the design process but were unintentionally left out of the final scope of work.
