SYNOPSIS

A motion is requested to approve the purchase of one 2008 Bomag BP4413 Asphalt Paver from West Side Tractor Sales Co. of Naperville, Illinois, as the lowest responsive and responsible bid in the amount of \$64,015.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2007-2012 identified *Exceptional Municipal Organization*. A supporting objective of this goal is *Top Quality Core Services Responsive to Current and Future Community and Citizen Needs*.

FISCAL IMPACT

The FY08 Equipment Replacement Fund budget provides \$70,000 for this purchase.

RECOMMENDATION

Approval on the August 19, 2008 consent agenda

BACKGROUND

The Village currently owns and operates a 1992 LeeBoy 8000 asphalt paver. This piece of equipment is used for roadway maintenance and driveway approach repairs. As noted in the FY08 budget, this piece of equipment is scheduled to be replaced in 2008.

A Call for Bids was sent to four equipment distributors and published in accordance with the Village's Purchasing Policy. Three bids were received on May 14, 2008. A synopsis of the bids is as follows:

The bid submitted by Finkbiner Equipment Co. did not meet approximately half of the bid requirements and is therefore not a responsive bid. Staff believes the Bomag paver meets the bid specifications and will increase the Village's operational efficiency and meet customer expectations for the quality of in-house paving work. The larger hopper will provide more efficient paving; the more flexible paving width adjustment will allow for use of the machine in more areas; and the construction of the machine will improve serviceability and reduce future maintenance costs.

The Village of Schaumburg recently purchased this make/model paver and is very happy with it. Village staff visited Schaumburg and were impressed by its capabilities. Other municipal references included the City of Crystal Lake, Algonquin Township and the Lake County, Indiana Department of Transportation.
