SYNOPSIS

A motion is requested to authorize the purchase of two (2) additional 2009 Honda Civic GX compressed natural gas (CNG) sedans from Volvo Sales & Service Center, Inc., of Lisle, Illinois, in the amount of \$42,268.18. The purchase of the two additional Civic CNG vehicles would replace the planned purchase of two compact four-door hybrid electric utility vehicles with a cost of \$63,490.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2007-2012 identified *Exceptional Municipal Organization*. A supporting objective of this goal is *Top Quality Core Services Responsive to Current and Future Community and Citizen Needs*.

FISCAL IMPACT

The FY08 Equipment Replacement Fund budget includes \$208,000 for the replacement of eight vehicles in the Community Development Department. After an evaluation of the department's fleet, it was determined that a reduced fleet of six would satisfactorily meet the department's fleet needs. The budget for those six vehicles is \$156,000. On June 3, 2008, the Village Council approved the purchase of four (4) 2009 Honda Civic GX CNG sedans for \$84,536.36. Staff is requesting a change order in the amount of \$42,268.18 for an additional two (2) Honda Civic GX CNG sedans. Total cost for the purchase of six new vehicles would be \$126,804.54, which is \$29,195.46 under budget.

RECOMMENDATION

BACKGROUND

The Fleet Replacement Plan adopted by the Village Council as part of the FY08 budget includes the scheduled replacement of eight (8) vehicles in the Community Development Department. The purchase of four (4) replacement vehicles (Honda Civic GX CNG sedans) from Volvo Sales & Service Center of Lisle, Illinois, was authorized by the Village Council on June 3, 2008. Two of the eight scheduled replacement vehicles are not being replaced but rather removed from the fleet.

The remaining two vehicles were planned to be replaced with compact four-door hybrid electric utility vehicles. Staff developed specifications for these vehicles and issued a call for bids in accordance with the Village's Purchasing Policy in August. Only one bid for Ford Escape hybrid electric utility vehicles was received from Packey Webb Ford of Downers Grove, Illinois, in the amount of \$63,490. This price is \$11,490 over budget, and due to high demand and limited supply, Ford cannot specify a delivery date, though the cars would likely not be received by the Village until late 2009 or early 2010.

After further analysis of vehicle use and availability options, staff is recommending a change order to the Village's existing contract with Volvo Sales & Service Center of Lisle, Illinois, for the purchase of two (2) additional Honda Civic GX CNG vehicles (\$9,731.82 under budget), instead of the Ford Escape hybrid

electric utility vehicles. The Illinois Alternative Fuel Rebate Program administered by the Illinois Environmental Protection Agency also provides rebates of \$4,000 per vehicle on the Honda Civic GX CNG sedans following purchase and delivery, lowering the out of pocket cost to \$17,134.09 per vehicle, or \$34,268.18 for the two vehicles.
