SYNOPSIS

As part of the FY09 Municipal Budget, staff will be recommending the creation of a Fee Schedule. This Fee Schedule would be included in the annual municipal budget and evaluated yearly. With the creation of a fee schedule, any proposed fee changes would be approved by the Village Council in conjunction with the municipal budget.

BACKGROUND

In a continuing effort to improve customer service, staff is developing a fee schedule for inclusion in the annual municipal budget document.

At present, the approximately 600 fees charged by the Village are contained within the Municipal Code, Administrative Regulations and Council Policies. These multiple locations have presented several issues for residents as well as Village staff. The multiple locations create unnecessary confusion for interested customers and have made it difficult to monitor cost recovery for specific, fee-based services. In addition, alterations in individual fee amounts require separate ordinances or resolutions. A fee schedule will move the existing fees from three sources into one Village Council Policy that can be evaluated and updated by the Village Council in conjunction with the municipal budget review.

The following three objectives are to be achieved with the creation of the fee schedule:

1. Create a customer- and staff-friendly fee schedule
2. Compare the Village's fees with other comparable communities' fees
3. Recommend changes in fees that are revenue neutral and/or recover Village costs

The recommended process for creating a fee schedule and revising fees as necessary is as follows:

1. During the FY09 Municipal Budget preparation, staff will compile all fees that are found within the Municipal Code, Administrative Regulations and Council Policies and develop a fee schedule that can stand alone in one document. This schedule will then be included in the FY09 Recommended Budget.
2. In early 2009, staff will present the proposed Village Council Policy including all Village fees. This will also require amendments to the Village Code, Village Council Policies and Administrative Regulations that currently address fees.
3. Amendments to the fee schedule will be presented quarterly to the Village Council throughout 2009.
