Fairview Village - Rezoning and Preliminary Planned Development Amendment (west a. side of Fairview Avenue)

Action Requested: Approval by Ordinance

- **Purpose:** A Preliminary Planned Development Amendment to Planned Development #32 has been prepared for the seven parcels of Green Acres Subdivision. An ordinance has been prepared to change the zoning of seven residential parcels within the Green Acres Subdivision from R-3 (Single Family Residential) to R-5A (Townhouse Residential).
- b. Special Uses for a drive-through and car wash at 2125 Ogden

Approval by Ordinance Action Requested:

- **Purpose:** A Special Use Ordinance has been prepared to permit the following items: 1) a drivethrough convenience store in the B-3 zoning district and 2) a car wash in the B-3 zoning district at 2125 Ogden Avenue for a period of 24 months after the approval of the petition.
- Special Commercial Event License Agreement -Bonfield Express Foundation c.

Approval by Resolution Action Requested:

- **Purpose:** A resolution has been prepared to authorize a Special Commercial Event License Agreement between the Village of Downers Grove and the Bonfield Express Foundation to conduct the Bonfield Express 5K Run/Walk, a charity fundraiser, on Thursday, November 27, 2008. The 5K Run/Walk uses various streets in and around the Downtown Business District as well as hosting a post race event in the Public Parking Facility located at 945 Curtiss Street.
- Designate One Block of Lincoln Avenue to Part-Time 1-Way Operation During School d. Hours

Action Requested: Approval by Ordinance

**Purpose:** An ordinance has been prepared to amend sections of the Municipal Code regarding the part-time designation of one block of Lincoln Avenue, between Fairview Avenue and Cumnor Road to a one-way street between the hours of 8-9 AM and 2-3 PM during school days.

- a. County Zoning Petition #Z08-083 Trowbridge (2508-2520 College Road) Belmont Park Townhomes
  - **Purpose:** A resolution has been prepared to oppose a petition filed with DuPage County to rezone the properties at 2508-2520 College Road from County R-4 to County R-5 and grant a Conditional Use for a Planned Development on these properties to construct twenty-four (24) townhouse units. The petition is not consistent with the Village Future Land Use Map.

#### b. Bid: Brookbank Road Storm Water Pump Station - Project SW-028A

- **Purpose:** A motion has been prepared to authorize award of a contract for the Brookbank Road Storm Water Pump Station (CIP Project SW-028A) to Marc Kresmery Construction, LLC of Elgin, Illinois in the amount of \$47,256.
- c. Bid: 2008 Miscellaneous Storm Sewer Improvements (Cost Share Program) (Project SS -10.07.08)

**Purpose:** A motion has been prepared authorizing the execution of a contract for the 2008 Miscellaneous Storm Sewer Improvements (Project SS -10.07.08) in the amount of \$51,560.44 to C & H Sewer and Water Construction of Willowbrook, Illinois.

- d. Contract Award: Professional Engineering Services –Rogers Street Water Main Replacement Design
  - Purpose: A resolution has been prepared to authorize award of contracts for Phase I & II design work related to water main improvements for Rogers Street (Highland Avenue Maple Avenue) to Burns & McDonnell Engineering Co., Inc. of Downers Grove, Illinois, in the not-to-exceed amount of \$29,825.85. Early award of this contract will allow engineering services to begin in the fall of 2008 instead of the beginning of 2009.
- e. Change Order: Prentiss Creek Subwatershed B Storm Sewer and Sunridge Subdivision Watermain Replacement (CIP Projects SW-034, DR-015, & WA-016)
  - **Purpose:** A motion is requested to authorize the execution of a change order for the Prentiss Creek Subwatershed B Storm Sewer and Sunridge Subdivision Watermain Replacement (CIP Projects SW-034, DR-015, & WA-016) in the amount of \$53,111.34 to Brothers Asphalt Paving, Inc. of Addison, Illinois.
