**SYNOPSIS**

A motion has been prepared authorizing the execution of a contract for the 2008 Miscellaneous Storm Sewer Improvements (Project SS -10.07.08) in the amount of \$51,560.44 to C & H Sewer and Water Construction of Willowbrook, Illinois.

**STRATEGIC PLAN ALIGNMENT**

The Five Year Plan and Goals for 2007-2012 identified *Top Quality Village Infrastructure and Facilities*. A supporting objective of this goal is *Improve Neighborhood Infrastructure Curbs, Gutters, Streets, Sidewalks, Stormwater and Drainage System*.

**FISCAL IMPACT**

On August 5, 2008, the Council agreed to increase the amount for the Stormwater Project Cost-Share Program to \$50,000. To date, \$3,375 has been distributed to residents as reimbursement for construction of approved drainage systems. The low bid of \$51,560.44 will bring the total cost of the program to \$54,935.44. This program is in the General Fund.

**RECOMMENDATION**

Approval of the contract on the November 4, 2008, consent agenda.

**BACKGROUND**

The improvements represent the public portion of the Stormwater Project Cost-Share Program. Under the Council Policy *Maintenance of Storm Water Control Structures and Creek Channels*, the Village will try to provide a storm sewer structure within the Village right of way for connection of a storm sewer (underdrain) that alleviates flooding on private property, provided that the system is extended no more than 200 feet. The policy defines flooding as a depressional area, shared by at least two residents, that experiences ponding water for at least four days after a rain event. All applicants affected by these improvements qualify for the Stormwater Project Cost Share Program under these guidelines. The applicants will be connecting their private storm sewer systems to the proposed storm sewer improvements under this contract. The storm sewer improvements will alleviate several drainage issues that are not part of any future capital project. Descriptions of the general work to be conducted are provided below. Maps of work locations are attached:

- Installation of a parkway inlet/pipe and private property storm sewer near 4512 Saratoga Ave
- Installation of a parkway inlet/pipe near 5827 Lyman Ave
- Installation of a parkway inlet/pipe near 4936 Montgomery Ave
- Installation of a parkway inlet/pipe near 4334 Elm St

- Installation of a parkway inlet/pipe near 5140 Carpenter St
- Installation of a parkway inlet/pipe near 6906 Fairmount Ave
- Installation of a parkway inlet/pipe near 4836 Montgomery Ave
- Installation of a parkway inlet/pipe near 4901 Montgomery Ave

Bids for the 2008 Miscellaneous Storm Sewer Improvements were received on October 17, 2008. A total of eight (8) bids were received. The low bid received was from C & H Sewer and Water Construction of Willowbrook, Illinois. A summary of bids received is as follows:

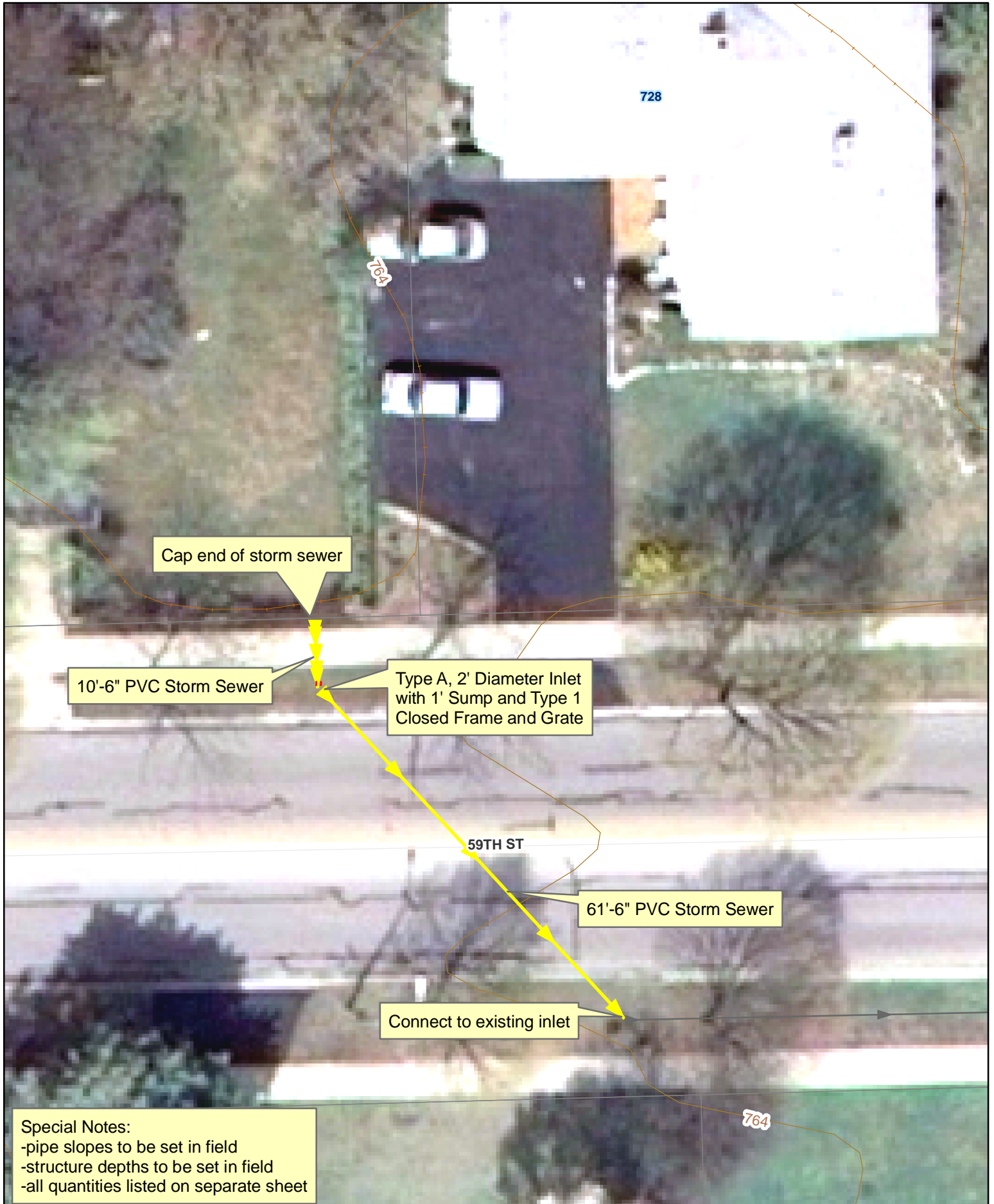

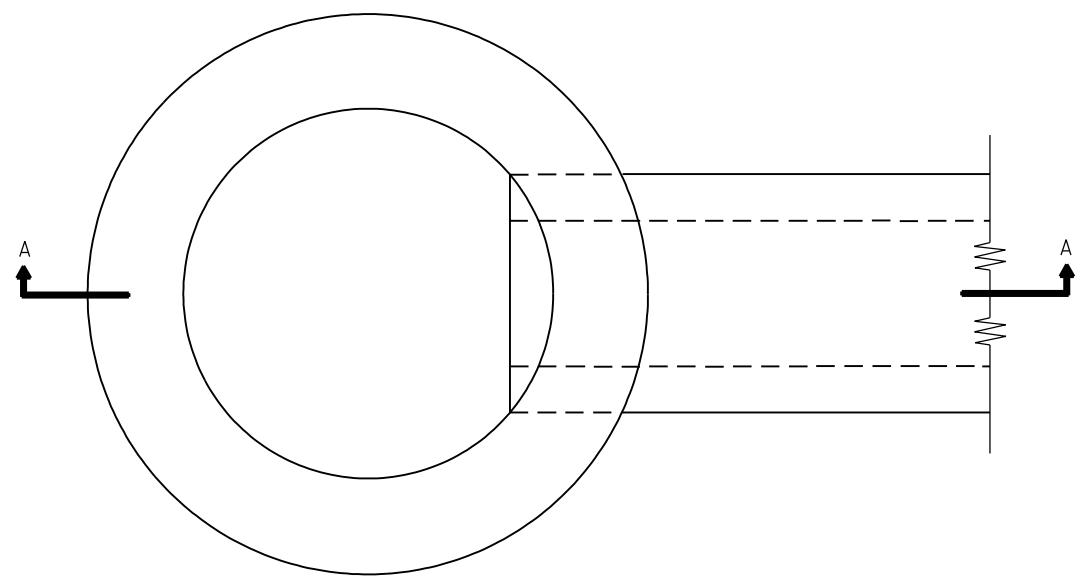




# Alternate 1: Frame/Inlet Replacements on Gilbert Ave

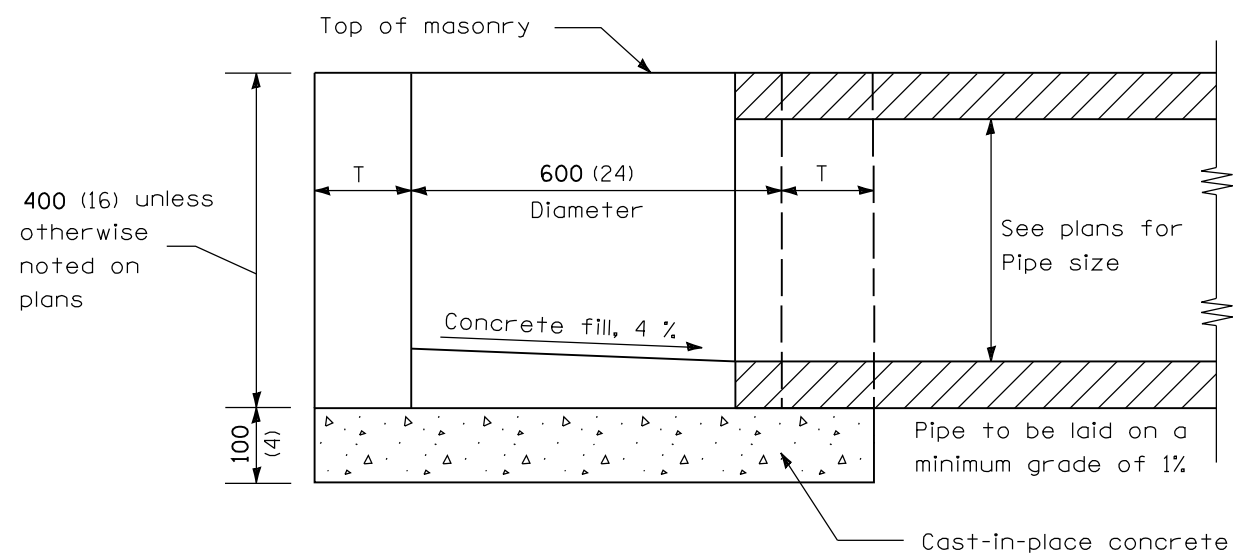




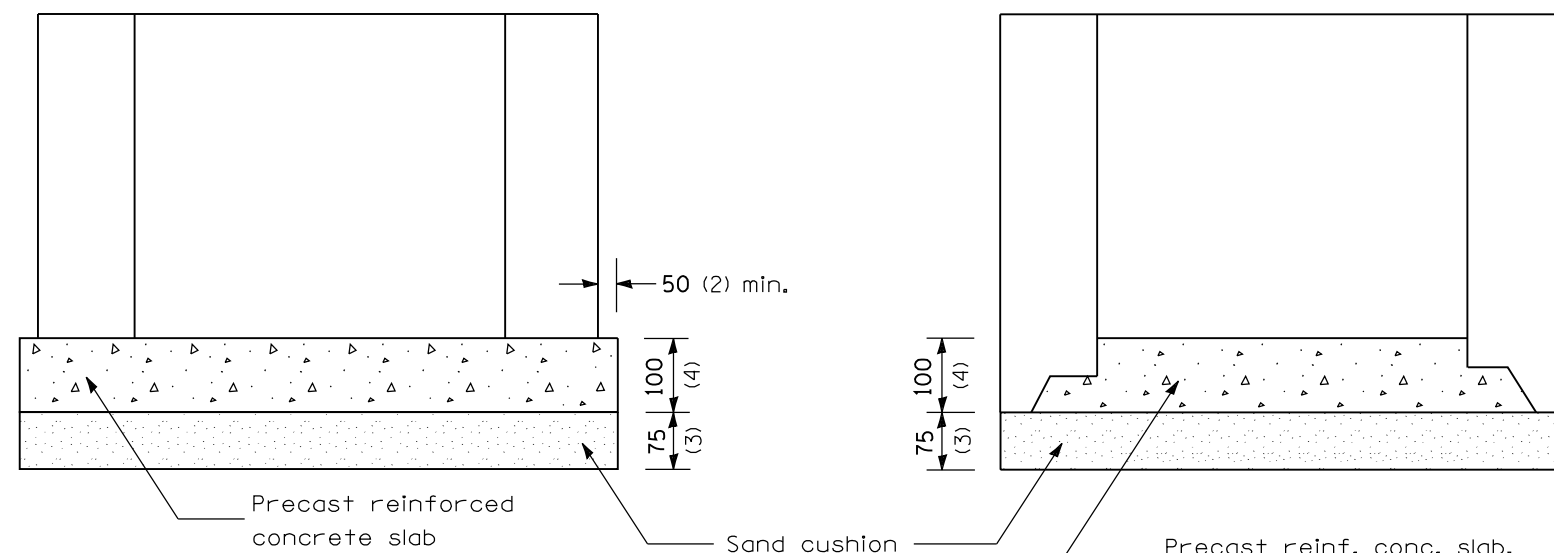


