SYNOPSIS

A motion has been prepared to award a contract for 2009 Parkway Tree Pruning Services to D. Ryan Tree & Landscaping LLC. of Dekalb, Illinois in the amount of \$111,884.00.

STRATEGIC PLAN ALIGNMENT

The 2008-2013 Strategic Plan identifies A *Beautiful Village* in the Downers Grove Vision 2023 statement. Associated objectives include *Tree Canopied Streets* and *Well Maintained Streetscapes, Green Spaces and Landscapes*.

FISCAL IMPACT

The approved FY09 budget provides \$112,000 in the General Fund for parkway tree pruning services.

RECOMMENDATION

Approval on the December 16, 2008 consent agenda.

BACKGROUND

The purpose of parkway tree pruning is to improve tree structure, enhance tree vigor, increase aesthetic appeal, provide adequate clearance, and maintain safe conditions in the right-of-way. All trees will be thoroughly pruned with the exception of ash trees. Similar to the 2008 contract, staff determined that ash trees need some pruning because there are so many with branch clearance issues, but not as thorough pruning because of the threat of Emerald Ash Borer (EAB) beetle infestations in the next 3 years. The contract specifies that ash trees are to be pruned for clearance, and for the removal of broken branches and deadwood over 4" diameter. For these reasons, contractors were asked to bid the price for ash trees separately from other species.

The optimum tree pruning cycle is to have each parkway tree is pruned once in five years. Since FY07, the Village operated on a five year pruning cycle (the Village had been operating on an eight year cycle prior to FY07). FY09 will be the 3rd year of a five year cycle. Areas scheduled for pruning in 2009 are shown on the attached map and includes all areas that were last pruned before 2001. All of these areas also had the highest number of resident calls for pruning requests and branch failures. Over the next few years, as a five year pruning cycle is implemented and completed, healthy trees will be maintained and resident requests for pruning and broken branches will decrease.

In October 2008, a Call for Bids for parkway tree pruning services was issued and published in accordance with the Village's Purchasing Policy. The bids received are summarized in the table below:



The bid submitted by GroundsKeeper Landscape Care LLC did not meet bid requirements due to the fact that the vendor was not able to provide municipal references for parkway tree pruning contracts in excess of 1,500 trees within the last 5 years.

The next lowest responsive and responsible bidder was D. Ryan Tree & Landscaping LLC of DeKalb, Illinois. Their municipal references were all positive and were all for pruning contracts in excess of 1,500 trees. This contract will be their first with Downers Grove. With regard to the significantly lower contract price, the owner of D.Ryan Tree & Landscaping LLC indicated he was very interested in working more in the area, and priced the pruning work accordingly. For reference, the FY08 pruning contract cost \$159,630.60.
