## **SYNOPSIS**

A motion is requested to award a contract for FY09 Tree and Stump Removal services to D. Ryan Tree & Landscape, LLC. of Dekalb, Illinois in the amount of \$170,412.50.

#### STRATEGIC PLAN ALIGNMENT

The 2008-2013 Strategic Plan identifies A *Beautiful Village* in the Downers Grove Vision 2023 statement. Associated objectives include *Tree Canopied Streets* and *Well Maintained Streetscapes*, *Green Spaces and Landscapes*.

#### FISCAL IMPACT

The approved FY09 Budget provides \$170,000 in the General Fund for this service. This includes \$110,000 annually budgeted for tree and stump removal services plus an additional \$60,000 for ash tree removals.

#### RECOMMENDATION

Approval on the December 16, 2008 consent agenda.

#### **BACKGROUND**

The purpose of this contract is to remove trees and stumps from parkways, Village properties, and unimproved right-of-ways and alleys. These removals are necessary because of tree death, hazardous conditions, infectious diseases such as Dutch Elm Disease and to start reducing the ash tree population in preparation for the Emerald Ash Borer. The contract amount is based on removal trends and increased ash tree removal needs. The number of tree removals and stump removals are not equal to each other because of in-house removals, storm damage losses, and tree removals in unimproved right-of-ways where stumps may not be removed. The bid quantities for FY09 were scaled back from those of the FY08 contract due to budget constraints. For reference, the amount spent on this contract for FY08 was \$240,709.40.

A Call for Bids for tree and stump removal services was issued and published in October 2008 in accordance with the Village's Purchasing Policy. The bids received are summarized in the table below.

The bid submitted by Mike's Tree Service was incomplete and did not meet bid requirements. It is therefore not a responsive bid. Mike's Tree Service does not currently have a Certified Arborist on staff or have municipal references for parkway tree removal contracts in excess of 200 trees.

The next lowest responsive and responsible bidder is D. Ryan Tree & Landscaping LLC of DeKalb, Illinois. Their municipal references were all positive and are for removal contracts in excess of 200 trees. This contract will be their first with Downers Grove. Staff is satisfied that D. Ryan Tree & Landscaping LLC. meets the Village's specifications and that their removal work will be what is required.
