SYNOPSIS

A resolution has been prepared to award a contract for mowing services for 2009 to Alaniz Landscape Group, Inc. of Elgin, Illinois in an amount not to exceed \$27,676, which includes \$26,676 for routine mowing and \$1,000 for additional as needed mowing services at a rate of \$27/hour.

STRATEGIC PLAN ALIGNMENT

The 2008-2013 Strategic Plan identifies A *Beautiful Village* in the Downers Grove Vision 2023 statement. Associated objectives include *Well Maintained Streetscapes*, *Green Spaces and Landscapes*.

FISCAL IMPACT

The FY09 General Fund Budget includes \$36,000 for this service.

RECOMMENDATION

Approval on the January 20, 2009 consent agenda.

BACKGROUND

The purpose of this contract is for the mowing and trimming of turf located throughout the Village. The contract has three types of turf that vary by mowing frequency:

- Fine moving locations are the prominent Village property areas to be moved frequently or approximately once a week (estimated 28 moving events)
- Rough mowing locations need to be mowed less frequently or once every 3 weeks (estimated 9 mowing events)
- Very rough mowing locations are to be mowed once a month (estimated 6 mowing events)

In addition, hourly prices were also submitted in case additional mowing may be needed for locations not included in any of the above. A call for bids for mowing services was issued and published in November 2008 in accordance with the Village's Purchasing Policy. The bids received are summarized below.

The lowest responsive and responsible bidder is Alaniz Landscape Group, Inc. of Elgin, Illinois. Their references were all positive. This contract will be their first with Downers Grove. Staff is satisfied that Alaniz Landscape Group, Inc. meets the contract specifications and will effectively perform this work.
