SYNOPSIS

A resolution has been prepared to authorize the execution of the 2009 Amusement Ride Vendor Agreement, with Astro Amusement Company, Inc., to operate the amusement midway at the 2009 Heritage Festival.

STRATEGIC PLAN ALIGNMENT

Downers Grove Vision 2022 identified the principles of *Authentic Downtown-The Heart of Our Community* with the supporting means of: *More People Attracted to Downtown-Destination for Residents and Non-residents*.

FISCAL IMPACT

The FY 2009General Fund Budget includes funds for the Heritage Festival Street Fair with \$455,150 in projected expenses (HF \$422,150; July 4th \$33,000) and \$444,150 projected in revenue (HF \$435,650; July 4th \$8,500). The proposed Amusement Ride vendor is projected to generate \$150,000 in revenue for the Village of Downers Grove.

RECOMMENDATION

Approval on the January 20, 2009 consent agenda.

BACKGROUND

In November 2008, the Village published a Request for Proposals for the operation of the amusement area at the 2009 Heritage Festival. Two amusement companies submitted a response to the RFP, North American Midway Entertainment d/b/a Astro Amusements Co., Inc. and Windy City Amusement Inc. Windy City Inc. later faxed a letter to staff stating that they are already contracted for the 2009 season and would not be submitting a proposal. Astro Amusement Company submitted a complete proposal. The Community Events Commission, at their December 18, 2008 meeting recommended utilizing Astro Amusement Company as the 2009 Heritage Festival Amusement Ride Vendor.

Astro Amusement Company has provided quality service for the past several years and has proven they can handle an event of our magnitude.

Additionally,

- The village will receive \$650, per concession (game) at the event and \$1,100 per food concession, along with ride revenue receipts of, 40% of \$0 to \$100,000; 43% \$100K to \$150,000; 45% \$150K to \$225,000; and 50% over \$225K of the gross receipts.
- Astro employees having contact with children will be placed through a fingerprint/ background check with the cost will be split between the village and Astro. At the village's discretion, the Astro employees may only be checked through the National Sex Offender database.
- Astro supports our event by donating in sponsorship \$500 for ten portable toilets, and 550 special tickets for sponsorship.

• Astro also provides the following: the Bear Show with seating area, the Misting Tents and the Pipe Organ, which all adds to the attractiveness of the midway area.

Prices for tickets in 2009 will be as follows. A sheet of 30 pre-sale tickets will be \$30.00, Thursday night pay-one-price will be \$20 and the Friday morning kiddie pay-one-price will be \$15. A single ticket will be \$1.25 and on the day of the events a sheet of 22 tickets will be \$25.00. New for this year will be a super sheet of 55 tickets at \$60 per sheet. As a side note, individuals who do not want to purchase the \$20 pay-one- price on Thursdays ride preview may use presale tickets purchased earlier in June or individual tickets available that evening.
