SYNOPSIS

A motion is requested to pre-qualify a list of four (4) engineering firms for Phase III - Resident Engineering (RE) services associated with FY09 Community Investment Program (CIP) projects.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2008-2013 identifies *Top Quality Village Infrastructure and Facilities*. A supporting objective of this goal is *Improve neighborhood infrastructure: curbs, gutters, streets, sidewalks, stormwater and drainage system*.

FISCAL IMPACT

Funding for Phase III - RE services is included in the Stormwater Improvement, Water System and Downtown and Ogden TIF funds. The specific impact upon each fund will be discussed when each individual RE contract is presented to the Village Council for formal consideration.

RECOMMENDATION

Approval on the February 17, 2009 consent agenda.

BACKGROUND

The expanded FY09 CIP may require the utilization of Phase III - RE consultant services for the following projects:

•	SW-007	Lacey Creek Retaining Wall Replacement
•	SW-033	Sterling North Pond
•	BW-003	Bikeway Connections
•	WA-009	Austin Street Water Main Replacement
•	WA-013	Gierz & Wilson Water Main Replacement
•	WA-030	59th Street Water Main Replacement
•	WA-031	Rogers Street Water Main Replacement

To expedite the future project selection process, staff recommends the establishment of a short-list of consultants to be pre-approved to perform this work. No contracts are being brought forth for consideration at this time. Prior to requesting proposals for any of these projects, staff will perform a workload evaluation of in-house staff to determine whether the work may be conducted by internal staff. If the capacity exists, staff will not contract for the particular project under consideration.

A Request for Qualifications was issued on December 15, 2008 via the Village website. Twenty-seven (27) engineering firms responded to the request. A list of the responding firms has been attached to this report. The qualifications were evaluated by staff in terms of: proposed staff to supply the RE services, relevant (i.e. local government) experience, similarity of prior work, references as well as the

completeness and quality of their submittal. A list of the recommended RE firms and a summary of each firm's qualifications are provided below:

CHRISTOPHER B. BURKE ENGINEERING

Christopher Burke Engineering has extensive experience in providing Phase III Engineering services. Their construction engineering department has completed numerous construction projects of the type the Village is proposing and is very familiar with IDOT's inspection and documentation requirements. The proposed Resident Engineers are licensed Professional Engineers with over 65 years of construction engineering experience. Each has worked on multi-faceted projects and is well versed in all components of typical municipal construction projects. Clients include the Village of Downers Grove, Palos Park, Orland Park, and Chicago Ridge.
