SYNOPSIS

A resolution has been prepared authorizing a two-year contract extension with Claims Management Consultants to provide claim management services for workers compensation and general & auto liability claims against the Village.

STRATEGIC PLAN ALIGNMENT

The Village's Strategic Plan goals for 2008-2013 include Exceptional Municipal Organization. A supporting objective is Financially Sound and Sustainable Village government.

FISCAL IMPACT

The FY09 budget includes \$40,000 in the Risk Management Fund for this contract. Approval of the proposed contract would fix the cost of third party claims administration services at the 2006 price of \$38,200 annually for the next two years through April 30, 2011.

RECOMMENDATION

Approval on the February 17, 2009 consent agenda

BACKGROUND

Since 2006, Claims Management Consultants has been the third party claims administrator for the Village. The services which Claims Management Consultants has provided to the Village include the following:

- Claims monitoring for workers compensation and general / auto liability claims
- Independent medical examinations for employees
- Facilitation of claims reviews
- Maintenance of claims files

The proposed resolution would authorize a two-year extension of the current contract with Claims Management Consultants. Approval of the contract would allow the Village to fix the cost of third party claims administration at the 2006 rate for the next two years. Staff has been satisfied with the level of service provided by Claims Management Consultants in the past. The proposed contract extension would have a duration lasting until April 30, 2011.
