#### SYNOPSIS

A motion is requested to award a contract for the 2009 Traffic Sign Blanks in an amount not-to-exceed \$18,000 to US Standard Sign.

#### STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2008-2013 identified *Exceptional Municipal Organization*. A supporting objective of this goal is *Top Quality Core Services Responsive to Current and Future Community and Citizen Needs*.

#### FISCAL IMPACT

The FY09 budget includes \$18,000 in the General Fund for this project. The low bid is based on unit prices and is in the amount of \$31,366.00. The Village will not purchase materials beyond the budgeted amount.

#### **BACKGROUND**

Pursuant to the Purchasing Policy, the Village published a Call for Bids for this purchase. Bids were received from seven (7) vendors that provide this service, which will be in affect from January 1, 2009 through December 31, 2009.
