#### **SYNOPSIS**

A resolution has been prepared to award a contract for the McCollum Park Stormwater Improvements to Naperville Excavating Co. of Naperville, Illinois in the amount of \$1,175,303.28.

## STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2007-2012 identified *Top Quality Village Infrastructure and Facilities*. A supporting objective of this goal is *Improve Neighborhood Infrastructure Curbs*, *Gutters*, *Streets*, *Sidewalks*, *Stormwater and Drainage System*.

## **FISCAL IMPACT**

The FY09 budget includes \$1,250,000 in the Stormwater Fund for construction of the improvements at McCollum Park located in the Prentiss Creek, Sub B Subwatershed. The proceeds from the 2008 stormwater bond issuance will be used to pay for this project. Per the Intergovernmental Agreement with the Downers Grove Park District, the Village portion of the costs would be \$1,157,462.32 and the Park District portion of the costs would be \$17,840.96.

## RECOMMENDATION

Approval on the April 7, 2009 consent agenda. The project is pending approval from the Park District Board, taking place on Thursday, April 2, 2009.

## **BACKGROUND**

The contract is to provide stormwater detention in the form of one detention facility located at the northwest section of the Park District-owned property, McCollum Park. The detention facility, in conjunction with other projects, will alleviate drainage issues along Fairmount Ave from 61<sup>st</sup> Street to 67<sup>th</sup> Street and along 67<sup>th</sup> Street west of Blackstone Drive. Storage gained with the proposed detention basin will allow water to drain more efficiently from upstream areas, thus reducing flooding elevations. The project also consists of relocating a basketball court and volleyball court, the construction of a new soccer field with an underdrain system and irrigation system, and various park amenities.

In 2008 the Village and Downers Grove Park District executed an IGA that requires the Village to design and construct certain recreational improvements in exchange for the use Park District land for stormwater improvements.

Bids were received on Friday, March 13, 2009. Several items in the Alternate Bid have been included in the proposed contract amount. Selection of these items is scheduled to be approved by the Park District Board on April 2, 2009. Dollar amounts shown for the Base Bid and Alternate Bid represent the Village's best estimate regarding Park-District-selected items. A synopsis of the bids is as follows:

## Project status and completed work


