SYNOPSIS

A motion is requested to award a contract for the supply of fire hydrants to HD Supply Waterworks, Ltd. of Carol Stream, Illinois in the amount of \$48,500.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2008-2013 identified *Exceptional Municipal Organization* with the associated objective of *Top-Quality Core Services Responsive to Current and Future Community and Resident Needs*.

FISCAL IMPACT

The adopted FY09 Water Fund budget provides \$53,000 for the purchase of fire hydrants.

RECOMMENDATION

Approval on the April 7, 2009 consent agenda.

BACKGROUND

The supply of fire hydrants for 2009 was competitively bid, and resulted in five responses with bid results as shown in the table below. This purchase provides for materials to be used by the Department of Public Works for water system repairs at various locations throughout the Village.

Ziebell Water Service Products, Inc., Elk Grove Village, Illinois	\$50,350

The hydrant bid by the low bidder does not meet the Village's water distribution system specifications and therefore is not a responsive bid. The Village's construction specifications require the use of Waterous Pacer fire hydrants as bid by HD Supply Waterworks. These hydrants feature all ductile iron construction which is lighter and stronger. In addition, Waterous hydrants include features that reduce maintenance costs and improve the reliability and life of the hydrant resulting in an overall lower total cost of ownership. HD Supply Waterworks, Ltd. Supplied the Village with 16 fire hydrants in 2008. The hydrants were ordered and shipped in a timely manner and no problems were reported with the hydrants.
