#### SYNOPSIS

A resolution has been prepared authorizing the execution of a contract for water distribution valve assessment services in the amount of \$46,200 with M.E. Simpson Co., Inc. of Valparaiso, Indiana.

# STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identifies *Top Quality Village Infrastructure and Facilities*. A supporting objective of this goal is *Upgraded Water System*.

### **FISCAL IMPACT**

The adopted FY09 Water Fund budget provides \$85,000 for contractual water distribution valve assessment, exercising and locating services.

#### RECOMMENDATION

Approval on the April 7, 2009 consent agenda.

#### **BACKGROUND**

This program involves utilizing the services of a technical service company to exercise and assess the condition of 1,100 main line water distribution valves in the Village's water system. There are four components to a valve assessment program including:

- Locating the valves
- Fully exercising the valves
- Maintaining detailed valve records
- Scheduling and performing needed repairs

A Request for Proposals (RFP) seeking services from a qualified vendor to provide the valve assessment program was issued on February 20, 2009. The RFP was sent to three vendors and published on the Village's web site in accordance with established procurement procedures. One proposal was received by the due date of March 9, 2009 as follows:

Vendor	Cost Proposal	Cost Per Valve
M.E. Simpson Co., Inc., Valparaiso, Indiana	\$46,200	\$42

There was no clear indication on the lack of response other than the market for these services is relatively narrow. M.E. Simpson did complete this work in 2008 and performed well. Their price per valve in 2008 was \$56. Staff is confident that the proposed price is reasonable for the work being requested.

Provide details if early or late completion: The project was completed later then planned because M.E. Simpson was asked by Village staff to GPS locate and inspect several valves in the system that were replaced during water main projects and installe after M.E. Simpson already completed that area. M.E. Simpson was very concerned about giving us as much correct information as possible.
Change Orders (attach information if needed):
Difficulties / Positives: This project was the first of its kind for Downers Grove and M.E. Simpson did a good job. Their communication was excellent. They contacted staff as needed with valves that were un-keyable or questionable if they were found closed. They found 102 valves that were not on the water atlas. The project deliverables were very well written with explanations on all of the findings which will help us in evaluating our water system as well as replacing or repairing valves that were discovered inoperable. We were also expecting to have to replace many broken valves during this project. M.E. Simpson broke only two of 2,606 valves exercised which is an extremely good ratio. Another positive is having the ability to have all our valve info online with the Pro-Valve program.
