SYNOPSIS

A motion is requested to award a contract for the supply of ready mixed concrete to Elmhurst Chicago Stone Company of Elmhurst, Illinois, in the amount not to exceed \$26,515.60.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identified *Top Quality Village Infrastructure and Facilities*. A supporting objective was *Improve Neighborhood Infrastructure: Curbs, Gutters, Streets, Sidewalks, Stormwater and Drainage*.

FISCAL IMPACT

The FY09 Budget provides a total of \$28,250 for the purchase of ready mixed concrete. Of this total, \$23,000 is attributable to the General Fund and the remaining \$5,250 is provided in the Water Fund.

RECOMMENDATION

Approval on the April 21, 2009 consent agenda.

BACKGROUND

The supply of ready mixed concrete for 2009 was competitively bid with one response meeting specifications as summarized in the bid tabulation below.

The contract amount of \$26,515.60 is the vendor's initial cost estimate for ready mix concrete for approximately 300 yards of materials to be used by the Public Works Department for street repairs at various locations throughout the Village. Annual street repair work will begin in April and continue through October. The contract in 2008 was with Ozinga Illinois RMC and the prices last year ranged from \$95.53 per yard to \$113.94 per yard depending on the mix design.

There is no clear reason for the lack of bid responses. The Village has used Elmhurst Chicago Stone for ready mixed concrete in the past and has good experience with this firm.
