#### SYNOPSIS

A motion is requested to authorize award of a contract to E. Hoffman Inc. of Lombard, Illinois, for debris hauling and crushed limestone supply services in the amount not to exceed \$167,940.

### STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identified Top Quality Village Infrastructure and Facilities.

#### FISCAL IMPACT

The FY09 Municipal Budget includes \$269,830 for debris hauling and crushed limestone supply. Of this amount, \$66,880 is budgeted in the General Fund, \$134,250 is budgeted in the Stormwater Improvement Fund, and \$68,700 is budgeted in the Water Fund.

#### RECOMMENDATION

Approval on the April 21, 2009 consent agenda.

#### **BACKGROUND**

The contract to provide debris hauling and crushed limestone supply services was competitively bid for 2009 with nine bids received as summarized in the bid tabulation below. The contract amount is based on the hauling and disposal of approximately 640 semi-truck loads of debris as well as supplying about 2,350 tons of crushed limestone.
