SYNOPSIS

A motion is requested to authorize award of a contract for street sweeping maintenance services to Elgin Sweeping Services, Inc., of Chicago, Illinois, in the amount of \$107,934.90.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identified *Top Quality Village Infrastructure and Facilities*. A supporting objective of this goal is *Improved Stormwater and Drainage System*. Further, the Strategic Plan identifies the *Management of the Stormwater and Drainage System* as one of the Core Service Businesses of the Village.

FISCAL IMPACT

The FY09 Budget includes a total of \$168,000 for Street Sweeping Services (\$122,000 in the General Fund and \$46,000 in the Stormwater Fund). The FY09 Budget for Street Sweeping Services originally planned for an additional nine street sweeping cycles above FY08 levels. Theses nine street sweeping cycles would have cost the Village an additional \$45,000 in FY09. As part of the FY09 Budget Implementation Plan, staff has reduced the number of street sweeping cycles in FY09 back to FY08 levels, resulting in a cost-savings for the Village without a reduction in service levels. The proposed contract amount of \$107,934.90 for Street Sweeping Services represents a net savings of \$60,065.10 for the Village in FY09.

RECOMMENDATION

Approval on the April 21, 2009 consent agenda.

BACKGROUND

The 2006 Stormwater Master Plan Update identified street sweeping as a key activity for the operation and maintenance of the Village's stormwater system. The contract to provide street sweeping services was competitively bid for FY09, with four bids received as summarized below. The contract amount is predominantly based on the number of curb lane miles swept by the contractor, though prices for some hourly work were requested specific to emergency response and special events sweeping.

Hoving Clean Sweep, LLC, West Chicago, Illinois	\$116,540

The level of service expected is as follows:

- Routine Street Sweeping: all curbed streets swept six times from mid-April through October
- Downtown Business District: swept 22 times from mid-April through October

- Fall Sweeping: all curbed streets swept three times mid-October through early December
- Municipal Parking Lots: swept six times from mid-April through October

Unimproved roadways (those without curb and gutter) are not swept as sweepers generally need to work against the edge of a curb to function.

Elgin Sweeping Services, Inc. of Chicago, Illinois successfully completed the Village's street sweeping program in 2007 at a contract price of \$109,933.50. They also provided positive references from the City of Elmhurst, the Village of Bloomingdale and the Village of Woodridge. Waste Management provided street sweeping services in 2008 at a contract price of \$105,230.
