### **S**YNOPSIS

A motion is requested to award a contract for the supply of hot mix asphalt materials to Central Blacktop Co., Inc. of LaGrange, Illinois, in the amount of \$65,000.

### STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identified *Top Quality Village Infrastructure and Facilities*. A supporting objective was *Improve Neighborhood Infrastructure: Curbs, Gutters, Streets, Sidewalks, Stormwater and Drainage*.

#### **FISCAL IMPACT**

The FY09 Budget provides \$65,000 in the Capital Projects Fund for the purchase of asphalt materials. Staff will limit expenditures of this unit price contract to stay within the approved budget.

### RECOMMENDATION

Approval on the April 21, 2009 consent agenda.

# BACKGROUND

The supply of asphalt materials for 2009 was competitively bid and resulted in two responses meeting specifications as summarized below.

Vendor	<b>Unit Cost Per Ton</b>
Central Blacktop Co., Inc., LaGrange, Illinois	\$53.40
Chicago Materials Corporation, Lemont, Illinois	\$57

This purchase provides for approximately 1,200 tons of materials to be used for street repairs at various locations throughout the Village. This price is free on board at the Central Blacktop hot mix plant in Hodgkins and will be picked up by Village staff when materials are needed. Annual street repair work will begin in April and continue through October. The contract in 2008 was with Chicago Materials Corporation and the price for asphalt materials in 2008 was \$46 per ton.

Central Blacktop is pre-qualified with the Illinois Department of Transportation for hot mix asphalt and the Village has used this supplier for asphalt many times in the past (prior to the establishment of Contractor Report Cards) and has had good experience with this firm.
