SYNOPSIS

A motion is requested to authorize award of a contract to Chicagoland Paving Contractors, Inc. of Lake Zurich, Illinois for pavement patching services in the amount of \$73,900.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identifies *Top Quality Village Infrastructure and Facilities*.

FISCAL IMPACT

The adopted FY09 Water Fund budget provides \$95,000 for pavement patching.

RECOMMENDATION

Approval on the May 5, 2009, consent agenda.

BACKGROUND

The contract for pavement patching was competitively bid for 2009, with four bids received as summarized below. The contract amount is based on patching approximately 600 square yards of pavement as well as smaller amounts of sidewalk and curb and gutter restoration generated as a result of water utility repairs.

The low bidder is Chicagoland Paving Contractors, Inc. This bidder has not previously completed work for Downers Grove; however, references were checked and indicated a positive work history. This bidder has successfully and satisfactorily performed work of similar scope on multiple projects for the Village of Woodridge, the Village of Winnetka and the City of Evanston.

By signing the bid documents, contractor/proposer/bidder/vendor agrees to refrain from making any campaign contributions as defined in Section 9-1.4 of the Election Code (10 ILCS 5/9-1.4) to any Village Council member and any challengers seeking to serve as a member of the Downers Grove Village Council.
