SYNOPSIS

A motion is requested to award a contract for the Rogers Street Water Main Replacement Project to Swallow Construction of Downers Grove, Illinois in the amount of \$626,000.00.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2008-2013 identified *Top Quality Village Infrastructure and Facilities*. A high priority policy action for this goal is *Safe Water*, *Reliable Service*

FISCAL IMPACT

The FY09 Budget includes \$900,000 in the Water Fund for this project.

RECOMMENDATION

Approval on the May 19, 2009 consent agenda.

BACKGROUND

The Rogers Street Water Main Replacement Project is scheduled for 2009. The proposed improvements include replacement of water main on Rogers Street between Highland Avenue and Maple Avenue. The work will consist of the replacement of approximately 4,102 linear feet of 8-inch diameter ductile iron water main, replacement of approximately 65 residential water services, and other associated work. This project is necessary due to the numerous water main breaks experienced in these areas and the condition of the pipe. Road resurfacing and parkway restoration work will be handled under the Rogers Street Resurfacing Project.

A total of 16 bids were received on Tuesday, April 28, 2009. A synopsis of the bids is as follows:


