1. Call to Order

Mayor Ron Sandack called the regular meeting of the Village Council of the Village of Downers Grove to order at 7:00 p.m. in the Council Chambers of the Downers Grove Village Hall.

Pledge of Allegiance to the Flag

Mayor Sandack asked the Cub Scouts from Pack 80 to help lead those present in the Pledge of Allegiance to the Flag.

The Council meeting is broadcast over the local FM radio station, WDGC. In addition, a tape recording and videotape of the meeting are being made using Village owned equipment. The videotape of the meeting will be used for later rebroadcast of the Council meeting over the Village cable television Channel 6.

The Council will follow the rules of conduct for this meeting as provided in Sec. 2.5 of the Downers Grove Municipal Code. These offer the public the opportunity to comment at several points in the meeting. First, immediately following approval of the minutes of the past meetings, an opportunity will be given for public comments and questions on the active agenda items for this evening's meeting. Following this, an opportunity is given for public comments and questions on any subject. Finally, if a public hearing is scheduled for this meeting, an opportunity is given for public comments and questions related to the subject of the hearing.

The presiding officer will ask, at the appropriate time, if there are any comments from the public. If anyone wishes to speak, the individual should raise their hand to be recognized and, after acknowledgment from the presiding officer, approach the microphone and state their name and address. Remarks should be limited to five minutes, and asked that individuals refrain from making repetitive statements.

Mayor Sandack said there are agendas located on either side of the Council Chambers, and he invited the audience to pick up an agenda and follow the progress of the Council meeting.

4. Public Comments and Questions

A. Comments and Questions on Active Agenda

There were none.

B. Comments and Questions on General Matters

1. John Hazard, 1029 Blanchard, spoke on behalf of the DuPage United Downers Grove Housing Team. He thanked the Council for the important role it played in encouraging first time home buyers in the Village. This is important in today's market where there are so many homes for sale, and no buyers. Some owners are facing foreclosure. This results in a chain effect. First time buyers have no mortgage to pay off and their purchase is not contingent on the sale of another house. This helps break the chain of increased properties that cannot be sold. Downers Grove is competing with other towns, and has access to programs that are advantageous to the buyers without cost to taxpayers. There is one program only available in Downers Grove. The group submitted a recommendation to the TCD3 process that these programs be aggressively promoted. He reviewed the programs. The first program is a mortgage credit certificate that allows first time buyers to subtract 20% in interest from the bottom line federal tax obligation. The credit can be taken for as long as the person owns the building. He said \$1.3 million is available this year in Downers Grove and can be accessed anytime in the next 2 1/2 years. The second program is the Federal Tax Stimulus credit that allows \$8,000 to be deducted from income taxes, if this is done by November 2009. Mr. Hazard showed a slide of the brochure that will be distributed to offices, banks and businesses, and was distributed at Heritage Festival. The brochure is also available in Village Hall and Public Works. The idea needs to be wrapped into a much larger marketing plan, and the information must be disseminated to the public. He said the flyer is available at Village Hall. Mr. Hazard thanked the Council for taking steps to help first time buyers.

2. Frank Falesch, 820 Prairie, said that he was concerned that the Park Board and the Village

do not seem to be communicating with regard to trees that are to be removed. At a recent Park Board meeting, Mr. Falesch understood they were removing some trees because they might die. He doesn't see why they are removed before they die. Mayor Sandack responded that some field conditions were discussed. Every effort to avoid removing trees is being taken. Roots extended beyond the drip line and are in the footings of the project. He said that the setback is not relevant in this situation. Trees grow and you don't know how the root lines grow until the digging begins.

Mr. Falesch then addressed a street light and pole that was in line with his west property line. That pole was moved to the east at a lower elevation, which provides less light. He asked why it was moved. The Mayor said that staff would look into this and let him now.
