#### **SYNOPSIS**

A resolution has been prepared authorizing an agreement for a one-year extension for administrative hearing services with Victor Puscas of Aurora, Illinois in the amount of \$4,600.

#### STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2008-2013 identified *Exceptional Municipal Organization*. A supporting objective of this goal is *Village Government Trusted and Respected by Residents*.

#### FISCAL IMPACT

The FY09 Budget provides \$4,600 in the General Fund for this service.

#### RECOMMENDATION

Approval on the August 11, 2009 consent agenda.

#### **BACKGROUND**

Officer Victor Puscas has overseen the Police Department's administrative tow hearings for the past several years. In 2008, the Village completed a competitive, qualification based selection for administrative tow hearing services and Mr. Puscas was again selected to continue in his role as an Administrative Hearing Officer. The Village enacted a one-year agreement with Mr. Puscas on August 28, 2008.

Per the Village's purchasing policy, contracts may be extended a maximum of two times in the event the cost of the service does not increase more than 2%. Mr. Puscas has agreed not to increase his hourly rate or make any changes to the original agreement. Staff has been very pleased with Mr. Puscas' services and is recommending that his contract be extended for a period of one year.
