1. Active Agenda and Informational Items

These items will be discussed during the Workshop and acted upon individually by the Village Council during the active agenda portion of the next Council Meeting, unless otherwise noted. Informational items require no action by the Village Council.

- a. First Amendment to the Redevelopment Agreement for Acadia on the Green
 Action Requested: Approval by ordinance and resolution
 Purpose: An ordinance and resolutions have been prepared to amend the redevelopment agreement between the Village and Acadia OTG LLC.
- b. Zoning Map Amendment, Final Planned Development with a Variance, Final Plat of Subdivision, and Special Use for 715-719 Rogers Street
 - Action Requested: Approval by ordinance and resolution
 - **Purpose:** An ordinance has been prepared to change the zoning of two manufacturing parcels at 715-719 Rogers Street from M-1 (Light Manufacturing) to DT (Downtown Transition). An ordinance has been prepared for a Final Planned Development with a Variance to construct 16 townhouses. A Plat of Subdivision resolution has been prepared that will subdivide the two separate parcels into 17 individual parcels. A Special Use Ordinance has been prepared for dwellings exceeding one unit per 4,000 square feet of land area.
- c. Adoption of Updated Building Codes and Locally Administered Elevator Safety Program Action Requested: Approval by ordinance and resolution
 - **Purpose:** Ordinances have been prepared adopting the International Code Council's (ICC) 2006 series of building and fire codes, the 2008 National Electrical Code, and updated amendments to the 2004 State of Illinois Plumbing Code. Additionally, a resolution has been prepared entering the Village into an agreement with the State of Illinois for locally administering an Elevator Safety Program.
- d. New Belmont Road Commuter Parking Lots Lot J and Lot K
 - Action Requested: Approval by ordinance


Purpose: An ordinance has been prepared to amend sections of the Municipal Code to add two new Village-maintained parking lots (Lot J and Lot K) at the Belmont Road Metra Station and correct inconsistencies in the Code for other Village parking lots.

2. Consent Agenda Items

- a. Bid: Prentiss Creek Area Hybrid Street Lights (SL-002)
 - **Purpose:** A resolution has been prepared to approve the purchase of 25 hybrid wind and solar powered LED streetlights from King Luminaire Inc. of Jefferson, Ohio, in the amount of \$270,000.
- b. Bid: Supply of Public Works Uniforms & Outerwear
 - **Purpose:** A motion is requested to approve a contract with G&K Services of Minnetonka, Minnesota for the supply of public works uniforms and outerwear for in the amount of \$18,983.25.

- Amendments to License Agreements with Sprint Nextel d. Resolutions have been prepared authorizing four amendments to existing License **Purpose:** Agreements between the Village of Downers Grove and Sprint Nextel Corporation to install, maintain and operate antenna equipment on Village property.
