SYNOPSIS

A motion is requested to approve a contract with G&K Services of Minnetonka, Minnesota for the supply of public works uniforms and outerwear for in the amount of \$18,983.25.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2008-2013 identified *Exceptional Municipal Organization* and the supporting objective of *Top Quality Core Services Responsive to Current and Future Community and Citizen Needs*.

FISCAL IMPACT

The FY09 budget includes a combined total of \$30,600 in the General Fund, Water Fund and Fleet Services Funds for the purchase of Public Works employee uniforms and outerwear.

RECOMMENDATION

Approval on the September 15, 2009, consent agenda.

BACKGROUND

Personnel in the Public Works Department are allowed a fixed dollar amount annually for the purchase of uniforms and outerwear. To obtain competitive pricing, a consistent appearance standard and the accommodation of some personal preferences, competitive bids are obtained for selected uniforms and outerwear. Employees then order what they need from among the uniform bid items as long as they stay within their allowance for the year.

Pricing for the supply of Public Works uniforms and outerwear was obtained through the competitive bidding process in accordance with the Village's Purchasing Policy. Six companies placed a bid on the uniform products with results summarized below.

After reviewing all six bids, the lowest bid meeting specifications was submitted by G&K Services. Although the Village has not used G&K Services previously, several positive municipal references were supplied from local communities such as the Villages of Addison, Hinsdale, Buffalo Grove and Barrington.
