#### **SYNOPSIS**

A resolution has been prepared to approve a two-year extension to the contract for medical billing services with Andres Medical Billing Ltd. of Arlington Heights, Illinois.

#### STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2008-2013 identified *Exceptional Municipal Organization*. A supporting objective is *Financially Sound and Sustainable Village Government*.

#### **FISCAL IMPACT**

The FY09 budget includes \$50,000 in the General Fund for the medical billing contract.

#### RECOMMENDATION

Approval on the October 6, 2009 consent agenda.

#### **BACKGROUND**

On April 29, 2008, the Village Council approved a one-year contract with Andres Medical Billing Ltd. to provide billing services for the collection of fees for ambulance services rendered by the Village. Payment for the ambulance services are paid primarily by the patient's Medicare, Medicaid, private insurance and/or self payment. Per the existing contract, the Village pays Andres an amount equal to six percent (6%) of the revenue collected by the Village.

The Village has had a long relationship with the Andre's Medical Billing. The vendor has a history of providing excellent customer service and extremely accurate financial reports. Per the Village's purchasing policy, contracts may be extended a maximum of two times in the event the cost of the service does not increase more than 2%. Andres Medical Billing has agreed to extend the contract for a two-year period with no changes proposed in the cost of medical billing services.
