SYNOPSIS

A motion is requested to authorize issuance of a 2010 Class A Scavenger License to Republic Services, Inc, also known as ARC Disposal and Recycling, Inc.

BACKGROUND

The Municipal Code requires that the Village Council annually approve a Class A Scavenger License for the Village's designated contractual waste hauler. ARC Disposal and Recycling currently holds the Class A License and is under contract with the Village through March 30, 2011. ARC Disposal & Recycling is a wholly owned subsidiary of Republic Services, Inc. and is in the process of re-branding the company to reflect the parent company's name/logo. Thus, the 2010 Class A Scavenger License will be issued to Republic Services, Inc. to reflect this rebranding effort.

All other haulers that operate in the Village must obtain a Class B License, which allows the licenseholder to provide services other than weekly single-family residential solid waste collection. Renewal of a Class B license requires approval by the Village Manager, following notification to the Village Council. The Village has received the following Class B scavenger applications:
