SYNOPSIS

Motions are requested to approve a police equipment and police uniform contract with Ray O'Herron Company, Inc. of Lombard, Illinois. The contracts will be effective from January 1, 2010 to December 31, 2010.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2007-2012 identified *Exceptional Municipal Organization*. A supporting objective of this goal is *Top Quality Core Services Responsive to Current and Future Community and Residents Needs*.

FISCAL IMPACT

The adopted FY10 budget provides \$102,746 in the General Fund for this expenditure.

RECOMMENDATION

Approval on the December 8, 2009 consent agenda.

BACKGROUND

The proposed contracts would specify a vendor for police uniform and equipment purchases for a one-year period. Terms of the Collective Bargaining Agreement allow officers to purchase clothing or equipment at the fixed price established by the vendor with billing direct to the officer. Police Department uniforms may be purchased five ways: direct contract purchase, indirect contract purchase (as provided in the union contract), individual purchase of civilian clothing/equipment, other specialty items purchase and state tagalong contract purchase.

An official Request for Proposal process was conducted for police uniform and equipment. Ray O'Herron Co., Inc. was the only company to submit a bid on the equipment contract. Ray O'Herron Co., Inc. and Kale Uniforms of Wheaton, IL submitted bids on the uniform products. After reviewing the two bids and analyzing the price quotes on the most frequently purchased items by the police department, Ray O'Herron Co., Inc. offered the lowest overall bid.
