SYNOPSIS

A motion is requested to award a three-year contract for Tree and Stump Removal services to Homer Tree Care, Inc., of Lockport, Illinois in the amount of \$378,825.00.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals for 2008-2013 identifies *Top Quality Village Infrastructure and Facilities*. A supporting objective of this goal is *Maintain the Urban Forest*.

FISCAL IMPACT

The approved FY10 budget provides \$180,000 in the General Fund for this service. The proposed tree and stump removal contract would result in a total charge of \$126,275 for these services in FY10.

UPDATE & RECOMMENDATION

This item was discussed at the January 5, 2010 meeting. Staff recommends approval on the January 12, 2010 consent agenda.

BACKGROUND

The purpose of this contract is for the removal of trees and stumps from parkways, Village properties, and unimproved right-of-ways and alleys. These removals are necessary because of tree death, hazardous conditions, infectious diseases such as Dutch elm disease, and the need to reduce the ash tree population due to potential Emerald Ash Borer infestations.

A Call for Bids for tree and stump removal services was issued and published in October, 2009 in accordance with the Village's Purchasing Policy. Bidders were asked to provide prices for one year and for three years. The bids received are summarized in the following tables:





The lowest responsive and responsible bidder for both options is Homer Tree Care, Inc., of Lockport, Illinois. Their municipal references were all positive. Homer Tree Care Inc. has had this removal contract 12 times since 1990, most recently for FY08. Attached is the contractor evaluation form from FY08. Staff is satisfied that Homer Tree Care, Inc. meets the Village's specifications and that their removal work will be what is required for all three years.

The low bid by Homer Tree Care Inc. for each of the three years is significantly lower than expected. Unit prices this low have not occurred since 2004, as shown on the graphs. Given the current economic conditions and expense involved in disposing of wood debris, staff proposes a three year contract with Homer Tree Care, Inc. for this service.
