# SYNOPSIS

A motion is requested to award a three-year contract for Mowing Services to Waldschmidt & Associates, Inc. of West Chicago, Illinois in the amount of \$73,474.00 which includes \$3,000 for additional as needed mowing services (\$1,000 per year) at a rate of \$35/hour.

### STRATEGIC PLAN ALIGNMENT

The 2008-2013 Strategic Plan identifies A *Beautiful Village* in the Downers Grove Vision 2023 statement. Associated objectives include *Well Maintained Streetscapes, Green Spaces and Landscapes*.

# FISCAL IMPACT

The approved FY10 Budget provides \$36,000 in the General Fund for this service. The proposed mowing services contract would result in a total charge of \$23,603.00 for services in FY10 (\$22,603.00 bid plus additional mowing for \$1,000).

#### RECOMMENDATION

Approval on the January 19, 2010 consent agenda.

#### BACKGROUND

The purpose of this contract is for the mowing and trimming of turf located throughout the Village. The contract has 3 sets of locations that vary by their mowing frequency:

- Fine mowing locations are the prominent Village property areas to be mowed frequently or approximately once a week (estimated 28 mowing events)
- Rough mowing locations need to be mowed less frequently or once every 3 weeks (estimated 9 mowing events)
- Very rough mowing locations are to be mowed once a month (estimated 6 mowing events)

A Call for Bids for mowing services was issued and published in October, 2009 in accordance with the Village's Purchasing Policy. Bidders were asked to provide prices for both one-year and for three-year contracts. In addition, hourly prices were requested in case additional mowing may be needed for locations not included in any of the above. The bids received are summarized in the following tables:



The lowest responsive and responsible bidder for the three-year option is Waldschmidt & Associates, Inc. of West Chicago, Illinois. Their references were all positive. This contract will be their first with Downers Grove. Staff is satisfied that Waldschmidt & Associates, Inc. meets the Village's specifications and that their mowing work will be what is required for all three years.

Staff proposes a three-year contract for mowing services with Waldschmidt & Associates, Inc. For reference, the amount spent on this contract for FY09 was \$27,197, and staff had anticipated the bids to be in that range. The low bid by Waldschmidt & Associates, Inc. for each of the three years is lower than expected. Mowing prices this low have not occurred since 2004, as shown on the graph, even though the number of sites and total acres has increased over the years. Given the current economic conditions, it would be advantageous to lock-in this low pricing for three years.
