SYNOPSIS

A motion is requested to authorize award of a contract for roadside ditch reconstruction and maintenance services to Western Gradall Corporation of Naperville, Illinois, in the amount of \$84,000.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identified *Top Quality Village Infrastructure and Facilities*. A supporting objective of this goal is *Improved Stormwater and Drainage System*. Further, the Strategic Plan identifies the *Management of the Stormwater and Drainage System* as one of the Core Service Businesses of the Village.

FISCAL IMPACT

The FY10 Budget includes \$80,000 in the Stormwater Improvement Fund for roadside ditch reconstruction and maintenance services. The proposed contract for this work is over budget for this line item by \$4,000. Other expenditures within the Stormwater Improvement Fund are tracking below budget including street sweeping and debris hauling. Staff believes that savings in other areas within the Stormwater Improvement Fund will be sufficient over the course of 2010 to offset the remaining portion of this contract. As such, staff would prefer to maintain the recommended contract amount of \$84,000 necessary to stay on a 20-year roadside ditch maintenance cycle.

RECOMMENDATION

Approval on the April 13, 2010 consent agenda.

BACKGROUND

The 2006 Stormwater Master Plan Update identified roadway ditch cleaning as a key maintenance activity for the Village's stormwater system. Work is planned to be performed between April and September of FY10. The proposed contract would result in approximately three miles ditch reconstruction and maintenance in FY10. This contract was competitively bid, with the Village receiving two responses which met specifications. The bid results are summarized below.

Service Provider	Bid Price
Western Gradall Corporation, Naperville, Illinois	\$84,000
Copenhaver Construction, Gilberts, Illinois	\$193,200

The contract amount is based on the linear footage of roadside ditches to be re-graded. A third bid was received from Salce, Inc. of Downers Grove but this bid was determined to be non-responsive due to a lack of compliance with bid submission requirements. Of the two remaining bids, Western Grandall Corporation was deemed to be the most competitive in terms of price. Western Gradall has performed satisfactorily in the past for the Village and had the contract in 2009.
