SYNOPSIS

A motion is requested to award a contract for the 2010 Resurfacing (A) Project to Geneva Construction Company, Inc. of Aurora, Illinois in the amount not-to-exceed \$1,647,885.35.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identified *Top Quality Village Infrastructure and Facilities*.

FISCAL IMPACT

The adopted FY10 budget provides \$1,800,000 for this project (\$1,100,000 in the Motor Fuel Tax Fund and \$700,000 in the Capital Improvements Fund).

RECOMMENDATION

Approval on the April 13, 2010 consent agenda.

BACKGROUND

This contract is a component of the 2010 Roadway Maintenance Program (CIP Project ST-004). The contract also includes funding for the completion of the Rogers Street Resurfacing Project (CIP Project ST-023). The scope of work includes resurfacing selected Village streets with a new layer of asphalt along with the repair of defective sections of pavement and concrete curb and gutter. The streets included for resurfacing this year were initially presented to the Village Council for approval with the 2010 Motor Fuel Tax resolution on March 9, 2010. The remaining work for this year's roadway maintenance program will be allocated to projects bid at a later date as the 2010 Preventive Seal and 2010 Resurfacing (B) Contracts.

A Call for Bids (CFB) for was issued and published in accordance with the Village's Purchasing Policy. Six bids were received by the due date of March 23, 2010. A synopsis of the bids is as follows:

As the low bidder, Geneva Construction Co., Inc.'s proposed contract amount of \$1,647,885.35 is \$152,114.65 less than the budget of \$1,800,000. Geneva Construction satisfactorily completed the 39th Street Resurfacing Project for the Village in 2008. Additional references were also checked. This bidder has successfully and satisfactorily performed work of similar scope on multiple projects for the Village of Lisle and the City of Warrenville.



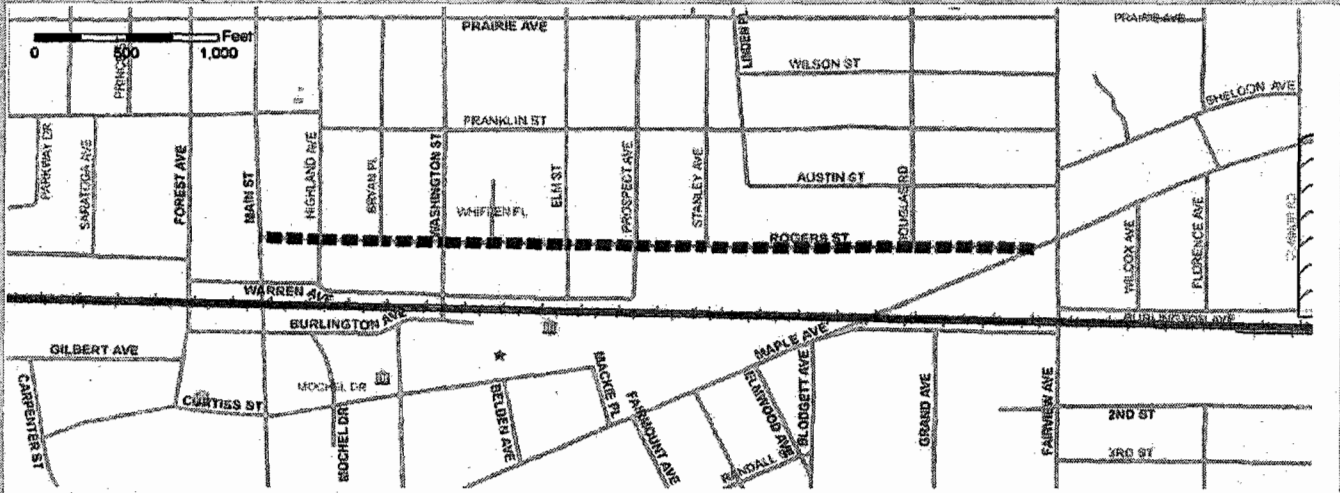
