SYNOPSIS

A resolution has been prepared to authorize execution of a modified agreement with DuPage County, Illinois for Community Development Block Grant (CDBG) Agreement CD09-20b related to the funding of hybrid streetlights in the Prentiss Creek Neighborhood.

BACKGROUND

This CBDG grant provided funding for the installation of wind and solar power hybrid streetlights in the Prentiss Creek Neighborhood. The original agreement was approved by Council on April 21, 2009 and provided for funding of approximately 45% of the project cost, with a maximum amount of \$150,000. The project was recently completed, the streetlights are operational, and staff is in the process of completing payments to the material supplier and the contractor who installed the streetlights. The terms of the original agreement anticipated that payments would be completed for this project before the contract's expiration date. Because of delays related to final completion of the work the final payment is projected to occur in April 2010. The purpose of this modified agreement is to extend the agreement to September 30, 2010 to allow for project close-out and completion of payments related to the work.
