SYNOPSIS

A motion is requested to award a contract for the supply of hot mix asphalt materials to James D. Fiala Paving Co., Inc. of Bolingbrook, Illinois, in the amount of \$64,800.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identified *Top Quality Village Infrastructure and Facilities*.

FISCAL IMPACT

The FY10 Budget provides \$75,000 in the Capital Projects Fund for the purchase of asphalt materials.

RECOMMENDATION

Approval on the April 13, 2010 consent agenda.

BACKGROUND

The supply of asphalt materials for 2010 was competitively bid and resulted in three responses meeting specifications as summarized below.

Vendor	Unit Cost Per Ton
James D. Fiala Paving Co., Inc., Bolingbrook, Illinois	\$54
Chicago Materials Corporation, Lemont, Illinois	\$55
Central Blacktop Co., Inc., LaGrange, Illinois	\$57

This purchase provides for 1,200 tons of materials to be used for street repairs at various locations throughout the Village. At the proposed price staff will have the ability pickup and transport materials from the James D. Fiala hot mix plant in Romeoville when needed. Annual street repair work will begin in April and continue through October. The contract in 2009 was with Central Blacktop and the price for asphalt materials in 2009 was \$53.40 per ton.

James D. Fiala is pre-qualified with the Illinois Department of Transportation for hot mix asphalt and the Village has used this supplier for asphalt in the past (prior to the establishment of Contractor Report Cards) and has had good experience with this firm.





The Campaign Disclosure Certificate is required pursuant to the Village of Downers Grove Council Policy on Ethical Standards and is applicable to those campaign contributions made to any member of the Village Council.

Said Campaign Disclosure Certificate requires any individual or entity bidding to disclose campaign contributions, as defined in Section 9-1.4 of the Election Code (10 ILCS 5/9-1.4), made to current members of the Village Council within the five (5) year period preceding the date of the bid or proposal release.

By signing the bid documents, contractor/proposer/bidder/vendor agrees to refrain from making any campaign contributions as defined in Section 9-1.4 of the Election Code (10 ILCS 5/9-1.4) to any Village Council member and any challengers seeking to serve as a member of the Downers Grove Village Council.
