SYNOPSIS

A motion is requested to award a contract for the supply of ready mixed concrete to Elmhurst Chicago Stone of Elmhurst, Illinois in the amount not to exceed \$20,000.

STRATEGIC PLAN ALIGNMENT

The Five Year Plan and Goals identified Top Quality Village Infrastructure and Facilities.

FISCAL IMPACT

The FY10 Budget provides a total of \$20,000 in the General Fund for the purchase of ready mixed concrete. Staff will limit expenditures of this unit price contract to stay within the approved budget.

RECOMMENDATION

Approval on the April 13, 2010 consent agenda.

BACKGROUND

The supply of ready mixed concrete for 2010 was competitively bid with one response meeting specifications as summarized in the bid tabulation below.

The bid amount of \$26,515.60 is the vendor's initial cost estimate for ready mix concrete for 270 yards of materials to be used by the Public Works Department for street repairs at various locations throughout the Village. Annual street repair work will begin in April and continue through October. The contract in 2009 was with Elmhurst Chicago Stone and the prices last year ranged from \$113.64 per yard to \$154.57 per yard depending on the mix design.

Another bid was received from Ozinga Ready Mix Concrete, Inc. but this bid was determined to be nonresponsive due to lack of compliance with contract terms relative to insurance requirements and termination of contract.
