### **SYNOPSIS**

A Resolution has been prepared authorizing the execution an agreement for purchase of Electric Utility Service effective May 10, 2010 from Champion Energy Services for a period of three years.

# STRATEGIC PLAN ALIGNMENT

The Five Year Plan Goals for 2010-2014 identified *Exceptional Municipal Organization* objective of this goal is *Financially Sound and Sustainable Village Government*.

### **FISCAL IMPACT**

Current electric rates are \$.08053 per kilowatt hour (kwh). At the time the contract is executed, the new rate will be set. The rate under the new contract will be approximately .05585 per kwh. Based on this estimate, the new contract should save the Village approximately \$30,000 per year compared to the current price.

### RECOMMENDATION

Approval on the April 20, 2010 active agenda.

### **BACKGROUND**

The Village of Downers Grove has a franchise agreement with Commonwealth Edison (ComEd), where all Village facilities that are non-revenue generating receive electricity free of charge. In return, ComEd has the ability to use the Village's rights-of-way. The Village pays for electricity in the revenue generating facilities, including the parking deck, water pumping stations, train station and rental properties. For these facilities, ComEd is no longer interested in selling electricity on a retail basis.

An RFP was sent out for a Retail Electric Supplier for revenue generating facilities. The Village received responses from Integrys Energy and Champion Energy. Integrys Energy did not meet the requirements of the Village's RFP. The rate as of April 9, 2010 as quoted by Champion is .05585 per kwh. The actual rate will not be locked in until the contract is signed. The contract will likely be executed on April 21, 2010. Staff estimates that it should be close to the .05585 per kwh as quoted on April 9. This rate will be locked in for a three year contract. A three year contract is recommended to take advantage of historically low pricing in the energy market.
